Some of the things we offer the community are senior safety classes, monthly CPR training opportunities, in school fire safety instruction and residential lock boxes for those that might have mobility or health and accessibility concerns.

We respond to both emergency and non-emergency situations and have agreements with our surrounding communities to share emergency services when we are committed to an incident and unable to respond. Our department takes pride in the level of participation that we have within our community and the organizations that we are affiliated with. We strive to be role models as well as good stewards of the public's trust. We look forward to the relationships that are built and the agreements that we have entered into and development of stronger bonds between our agency and those we have contact with and work with.

The training center we invested in last year and established in a residential house next to the fire station has been put to good use with over 1000 hours of training and prop development put into the facility over the past year. This facility and its convenient location allows us to train and expand our skills for fire and medical responses as well as developing rescue techniques. This is an exciting opportunity and our personnel are glad to have it available. We are pleased to provide this community and the area residents with well trained and professional individuals that are able to respond and handle most emergencies.

Our "sharps" disposal program has grown over the last year and we are proud to announce that we properly disposed of and kept over 945 pounds of sharps out of the landfills. We are still one of the few places in DuPage County where individuals can safely dispose of their needles and sharp medical devices.

As we prepare to enter into 2019, we look forward to planning our 50th anniversary celebration. We have redesigned our patch and department logo, not just for the 50th, but for the future as well. We developed a new logo that fits with the unique aspect of this department and we consider ourselves having some of the finest firefighters and medics in the area and are proud to have a distinct look.

Annual Report 2018

The members of the Glenside Fire Protection District take great pride in providing the residents and visitors of the District with quality cost effective care each and every day.

District members responded to 2,437 requests for service in 2018, essentially equal to the number of calls in 2017. Of the 2,437 responses 1,829 were for Emergency Medical Services which accounted for 75.1% of all calls this year. Our Paramedics and Emergency Medical Technicians had contact with 1,462 patients and provided advanced life support to 685 of them.

Fire data included 69 fire specific incidents and 120 hazardous condition incidents (with no fire). There were also 199 service related calls (a 46.7% increase from 2017) with the primary reason to assist with a lock-out or an invalid assist. We also saw an increase in smoke detector activation calls (303 with no fire) of the 417 total false alarm related calls.



The Glenside Fire Protection District

History

The Glenside Fire Protection District was created in June of 1969 through a referendum approved by the voters of the Glen Ellyn Countryside unincorporated area and the voters of the Village of Glendale Heights. In October of 1970 a new fire station was dedicated and held 6 pieces of fire equipment and provided a training room and living areas for the firefighters. In 1984 there was an addition of two long apparatus bays on the west side of the original building and in 1994 a two phase renovation project was started. The first phase, the renovation of the apparatus bays and the underground fuel storage tanks was completed during 1994. However, the second phase, the demolition of the meeting room and living areas of the original building and the construction of new living areas and administrative offices had to wait for funding. In March of 2002, the residents of the Glenside Fire Protection District voted to approve a three million bond issue to renovate the 32 year old fire station. On July 31, 2004 the dedication of the renovated fire station was opened to the citizens for their inspection. The building which was funded by the citizens is expected to serve the community for the next century. The bond commitment was completed by the District in December, 2018. There have been five Fire Chiefs at Glenside over the years...the picture below shows four of those five.

District Profile



The Glenside Fire Protection District, formed by its citizens in 1969 and organized under the general laws of the State of Illinois providing for the organization and operation of fire protection districts and is now under the provisions of the Fire Protection District Act of the State of Illinois, as amended (70 ILCS 705/0.01 et seq.). The District is located in west suburban DuPage County, approximately 25 miles west of the City of Chicago. The District is a multi-million dollar operation protecting 34,000 citizens in the community 24 hours each day 365 days each year with a single station. The District is proud to have a new ISO Class 2 rating and was OSHA inspected during 2017 with no violations.

The District provides a full range of services to its residents including, but not limited to: fire suppression and emergency medical services, hazardous materials response, fire prevention and public education, juvenile fire setters and various community events .

Each day, 24 hours a day, a minimum of five persons (but often eight) are on duty to respond to a variety of emergency incidents. Monday through Friday from 8a.m. until 4:30p.m. an administrative staff of five additional personnel are on duty. Fire Chief Russell Wood and Deputy Chief Richard Cassady manage the daily operations.

Three Trustees are elected by the citizens of the fire district to administer the funds and set policies for the District. And three Commissioners, who were appointed by the Board of Trustees and served in the calendar year of 2018 to support the hiring and promotional processes of full-time firefighters for the District.

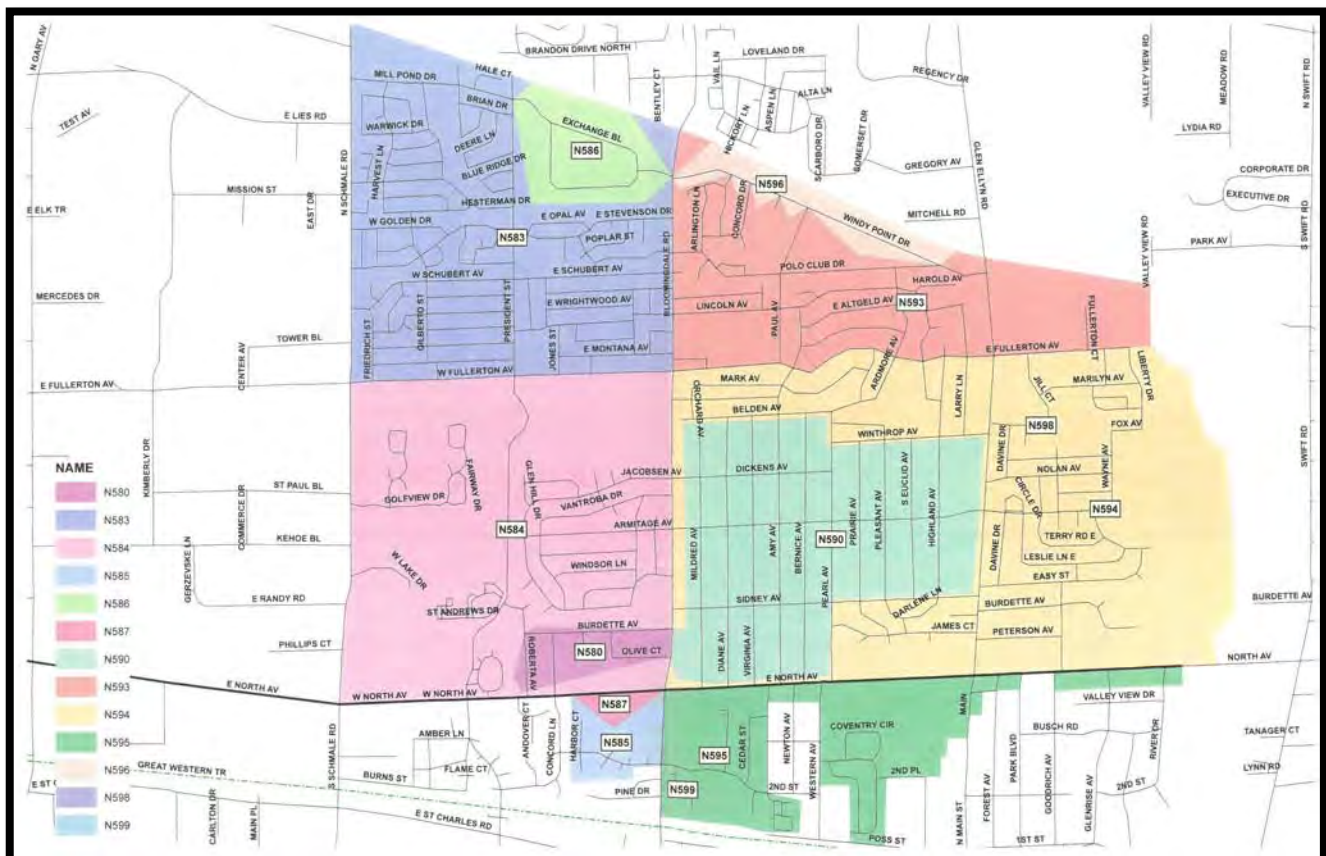

Continuing District Excellence with Best Business Practices

The new District training center was purchased in August, 2017.

The property is being used to train firefighters in disciplines such as single family structural firefighting, emergency medical services, hazardous materials and specialty rescue responses. Cooperative training exercises are also being completed with neighboring departments as well as MABAS IL Division 12 .

Pictures immediately below are of the modified interior rooms and some training exercises that took place in 2018. The training center has been utilized countless times resulting in over 1,000 hours of training for our firefighters in 2018.

March and April outdoor training pictures are related to roof training and exercises.

The location of the training center allows the firefighters to have more frequent hands-on training exercises and still be able to quickly respond to calls.

Foreign Fire Insurance Board

The Glenside Foreign Fire Insurance Tax Board was created within the department to receive and authorize the expense of funds for the maintenance, use and benefit of the District as well as its members, as designated by Illinois State Statute. The Illinois Municipal League collects 2% of fire related taxable premiums from all insurance companies in the state and provides it to all fire departments.

The Glenside Foreign Fire Insurance Board continued with another great year of focusing on the needs of the District and its members. In 2018, the board approved expenses for kitchen supplies in the living quarters as well as the admin kitchen areas. The purchase of the filtered water bottle stations for both the main and lower levels the year prior yielded the equivalent of approximately 5,600 disposable plastic bottles eliminated from the waste system over the past two years.

The board also continues to approve money to be spent on kitchen supplies that benefit all shifts and employees. Personal cancer screening was paid for and provided to all employees of the District as well. The overall importance of employee health is the focus of the board's intent for related expenses.

In addition, the money previously designated over the past three years to be used on the new workout/exercise room going into the basement of the District will be completed in the first half of 2019. New equipment for the room is expected to also be purchased in the upcoming calendar year. Firefighters are encouraged to work out on their shifts for an hour of physical activity. The dedication of the board will continue to assist the firefighters in their efforts to stay physically fit and assist them with the physical requirements of their daily jobs.

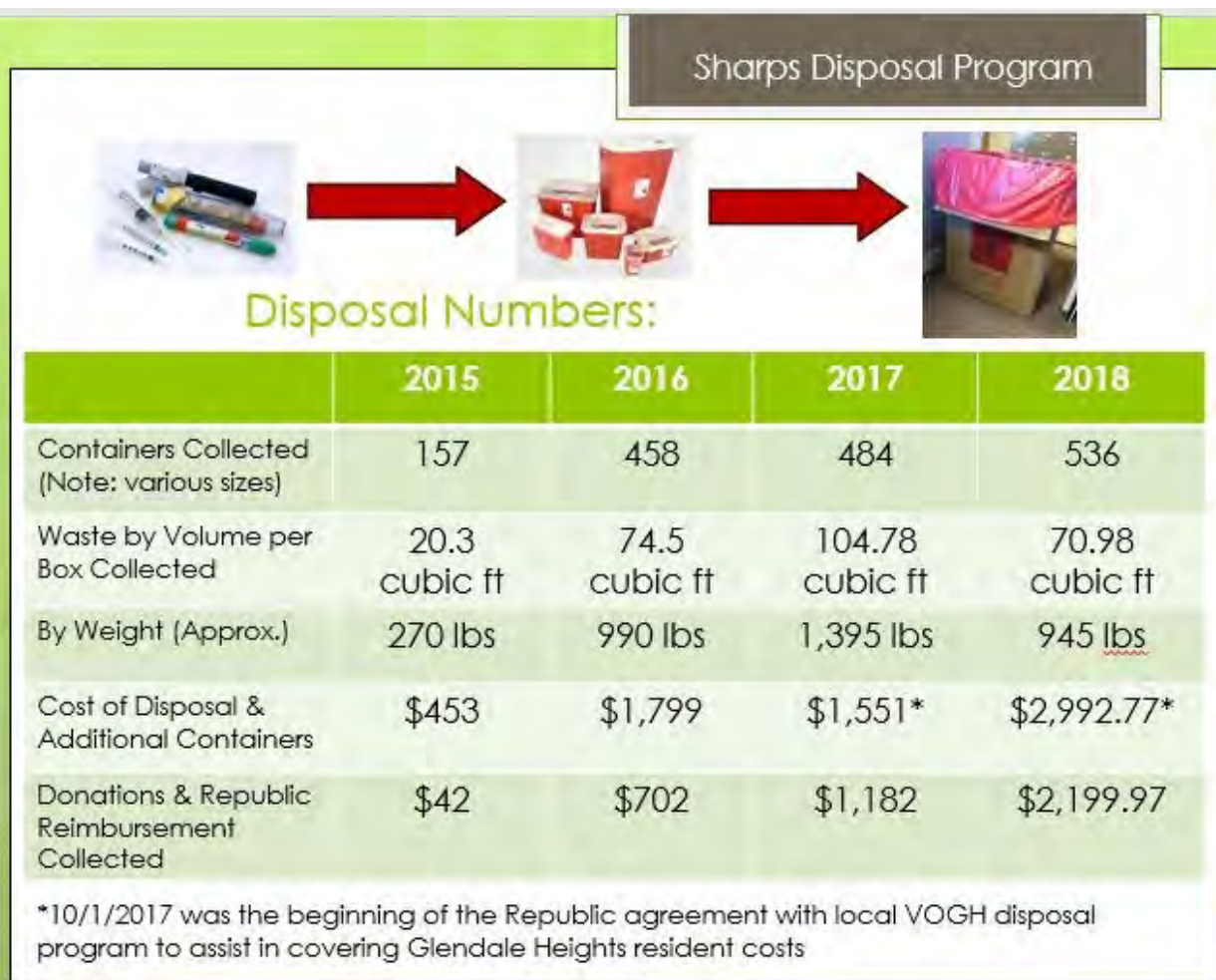

District Grants

Sharps Disposal Program



The District is proud to continue to be the leaders in DuPage County and in the State with the Sharps Disposal Program implemented in 2015. In late 2017, the Village of Glendale Heights' waste disposal company, Republic, contracted to partner with us and now provide a payment to supplement the cost of the program annually. We then continue to use a portion of the IPRF Safety Grant money to cover the remaining cost of the disposal and assist not only the citizens of the District but we also never turn away anyone disposing of sharps. Donations are received from all non-residents who are able to make one. The program has grown since its inception (see the disposal chart below) and is not only appreciated by those utilizing the program but encourages everyone to enhance their carbon footprint toward our environment. It is the District's hope that other fire departments will soon follow.



Incidents and Fire Loss



Weather is often times a challenge in the fire service with severe cold temperatures in the winter months and often times large amounts of snow as was seen on February 9th. Maintenance and clearing of snow in front and back of the fire station is critical as vehicles are called to duty on heavy snow days.



There were 120 hazardous condition incidents in 2018 or 4.93% of all calls, a 13% increase from 2017.

Strong winds can cause trees to be uprooted, cause power lines to come down and cause other hazardous conditions to residents and firefighters.

May 30, 2018 brought heavy rains to the area at high speeds and dumping 8-12 inches of rain at a time. Pictures to the right are along Fullerton Ave.



Incidents and Fire Loss



Dryer fires continue to be one of the primary reasons for a household fire. This fire occurred on January 23rd on Paddock.

This microwave fire on August 8th could have been avoided if the top of the microwave was clean and not piled with clothing.



Noteworthy Facts:

There were six cooking fires accounting for 9% of all fire categorized calls in our District. Cooking area fires caused approximately \$3,500 in damages down by 90% compared to 2017.

120 hazardous condition calls (with no fire) were primarily related to gas leaks, carbon monoxide and power lines being down.

Black Shift took the most calls (847) in 2018 with 34.76% of all calls and were the busiest on Mondays.

Incidents and Fire Loss



Fires can sometimes be in challenging locations. This one occurred in a crawl space on February 26th on Easy Street. Often times thermal imaging cameras will be used to confirm that a fire is completely out in the walls or other hard to see areas of a home.



Above pictures from a fire that occurred on March 10th on Wrightwood Ave. show a fire that originated in a residential attic.

A fire investigation was completed by Fire Inspectors Lipponeur and Little. There were a total of 16 Fire investigations performed in the calendar year of 2018.

Incidents and Fire Loss

Pictures below are from March 18th the first of 5 car fires for the year occurring in a car lot on North Ave. and again on Wrightwood Ave. on June 25th in front of a residence.



A small fire in a bathroom on November 29th was just a few blocks away from the fire station on Bloomingdale Road. The fire was quickly extinguished by Engine 58's crew.



Noteworthy Facts:

105 vehicle incidents occurred ranging from accident with injuries to rescue and extrication
5 of those incidents were vehicle fires accounting for 7% of all fires for the District

199 Service calls took place in 2018. 112 were citizen invalid assist and accounted for 56% of those categorized calls. 38 were related to lock-outs.

Incidents and Fire Loss



An auto aid call was received on April 7th for a house fire in Glen Ellyn that grew to a 2nd alarm fire with an origin location in the attic. Unfortunately this fire had a fatality. We encourage our residents to regularly check their smoke alarms for proper operation.

Glenside was first on the scene and were first to get water on the fire. Carol Stream Tower assisted from a higher level. Lt. Siewierski (pictures right) and his shift worked the scene that day.



Noteworthy Facts:

69 Fire specific calls were logged for 2018 - 32 building fires, 13 outside fires

124 No Fire related calls were logged

417 False alarm and false calls occurred in 2018, 17% of all calls responded to

Total estimated dollars lost for all calls in 2018 was recorded at \$167,965

Incidents and Fire Loss

The first real snowfall of November, 2018 resulted in wet, slick roads and the overturning of a semi-truck and its trailer at the corner of Glen Ellyn and Windy Point Roads. Firefighters are seen shoring the vehicle's cab so the driver could be assisted out. Luckily there were no major injuries and the vehicle was righted a short time later.

Safety message: Slow down on wet roads; black ice can take you by surprise when the temperature drops just below freezing.



An overturned pick-up truck on Bloomingdale Road in September, 2018 is shown below with scattered debris on the road from the vehicle's bed. Firefighters once again took steps to secure the vehicle before needing to extricate the driver through the roof.

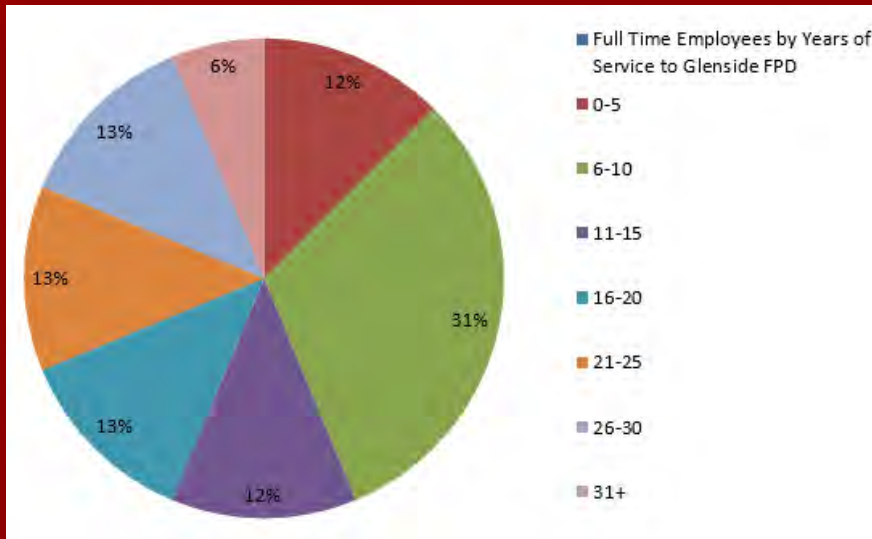

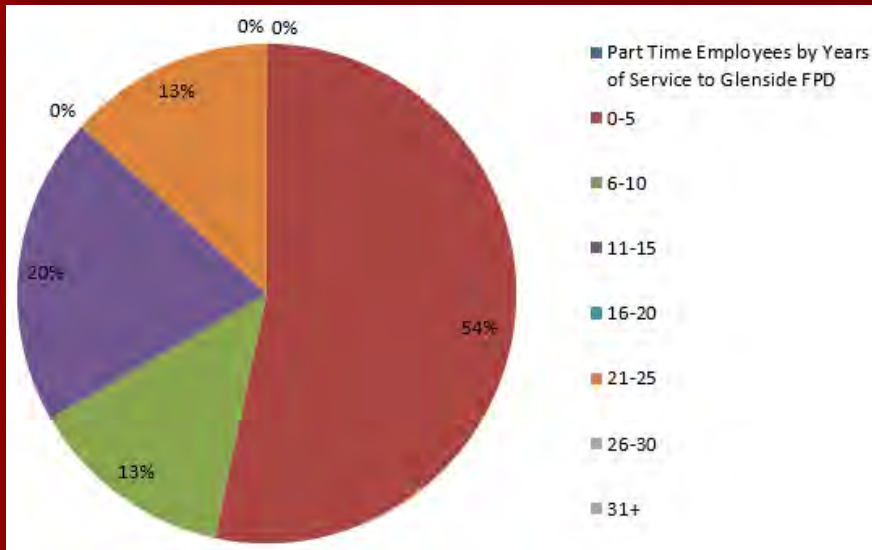

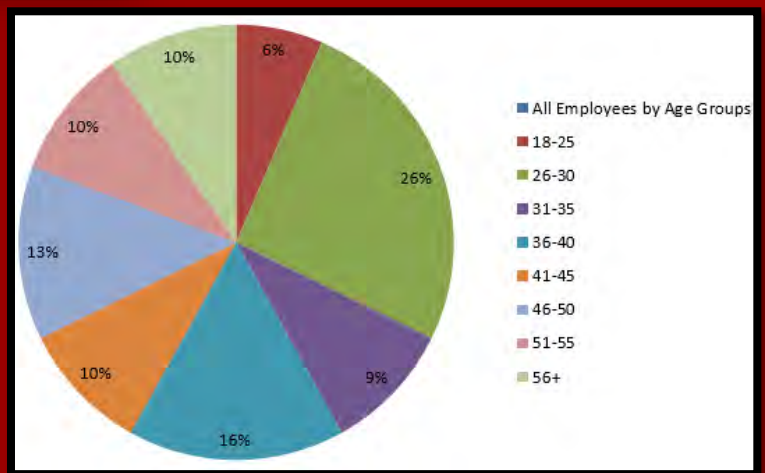
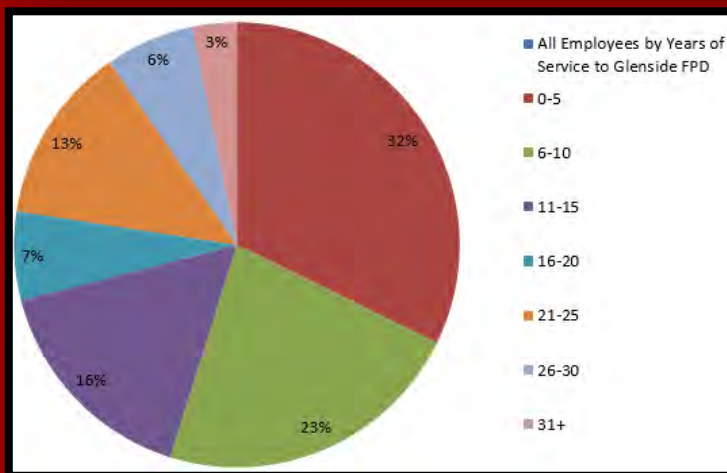
Graph charts show the demographics of the District members by years of service, both full-time and part-time (left and center).

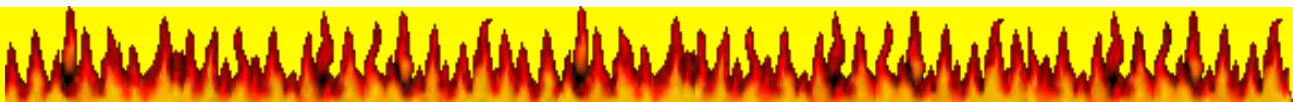

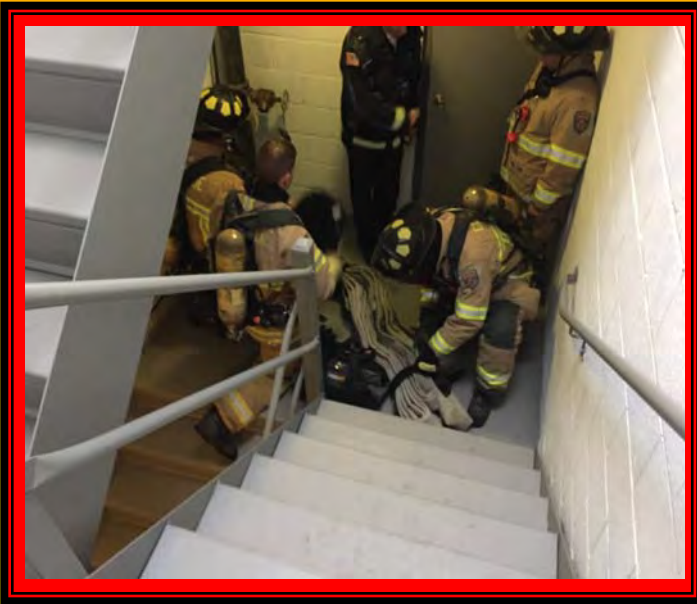

Training Classes & Exercises

Hose Training & Pre-Planning

Training exercises at 1074 Michael Dr. took place in November, 2017. Shortly thereafter, a kitchen fire occurred at 1042 Michael Drive in December that turned into a box alarm incident. Reinforcing why training and pre-planning are so important at a variety of buildings in the District, especially those with challenges. The Fire Marshal will coordinate with the trainees during these exercises to address any special circumstances of the location.



Noteworthy:

An average of 312 hours of training were provided to each firefighter in 2018!

The District recorded 2,485 hours of training for firefighters and EMT's in 2018 during a variety classes.

24 Continued education in the EMS field is required annually for all paramedics.

Hazardous Materials Training in 2018



October, 2018

Firefighters participated in hazardous material decontamination training drills with MABAS Division 12 located in Addison. MABAS Division 12 drills are coordinated internally by training officer Lt. Chris Cavanaugh. All firefighters are encouraged to attend the sessions.



March, 2018 Decontamination training took place on all shifts and on Wednesday night drill. Weekly training is made available to all employees.

District Training in 2018

In September, companies took part training in a flashover simulator at the Elmhurst FD training facility. The simulator is designed to replicate a dangerous condition known as “flashover” that can occur in a structure fire. The simulator provides a controlled environment in which firefighters can observe the rapid growth of a fire from an incipient stage to a fully developed stage. This valuable training is aimed at giving firefighters a better understanding of fire behavior and will aid them in recognizing the signs of a potentially deadly flashover event.

Outdoor Recreational Fire and effects of gasoline on fires

A tragic incident took place in April at an outdoor recreational fire in a backyard where several high school students were celebrating an end of year get together. Several of the teenagers were severely burned when gasoline was unsafely poured on the open flame of the fire. A public education training demonstration on the dangers of gasoline used on outdoor fire pits was performed by Glenside later that week by Chief Wood and shift firefighters. The news media was invited via press release and reported on several news stations to increase awareness of the dangers and hopefully decrease injuries in the future. A video of the demonstration was saved to work into the firefighters training reference files and

will be used in the future as needed for public education.



Community Awareness



Chief Wood and Paramedic/Firefighters Guevara and Ostrand addressed media questions and spoke to the events that occurred on the day of the incident. The Glenside Fire District invited the news media and performed a mock demonstration of the dangers of using gasoline on an open fire, particularly an outdoor fire pit. Information about safety around outdoor fires was reinforced and notation to the types of flammable clothing versus certain materials was addressed. The impact of cheap clothing and particularly synthetic materials worn around fires was also stressed. All natural materials like 100% cotton are best and will not burn as easily or melt, causing additional damage to an individual's skin.



Safety message:

Never add a flammable liquid to a fire, even if it is just smoldering.

In 2018, the District held 26 classes and trained 171 members of the public and/or businesses.

In August, Deputy Chief Cassady interviewed cardiac arrest survivor and public speaker, Ms. Heather Baker, on the benefits of learning CPR. With the assistance of the Village of Glendale Heights staff, a segment was filmed and aired on Glendale Heights TV. On February 1, 2018 Ms. Baker, at the age of 28, went into sudden cardiac arrest. Her co-workers at the Pecotonica, IL School District witnessed her collapse and immediately began CPR which saved Heather's life. The segment with Heather's incredible story was aimed at promoting the importance of learning CPR.

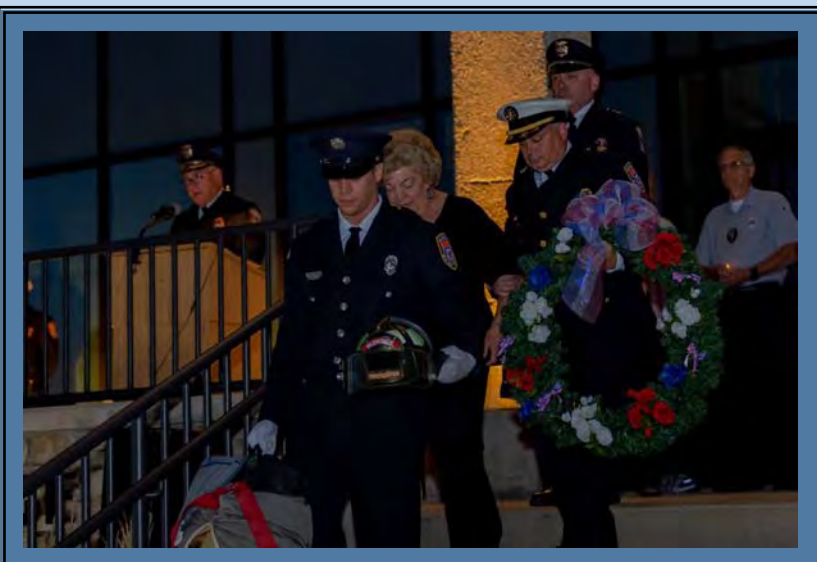


Patriot Day 2018

The firefighters served smoked pork loin sandwich, baked beans, pasta salad, chips, lemonade & brownies for dessert...yum yum!

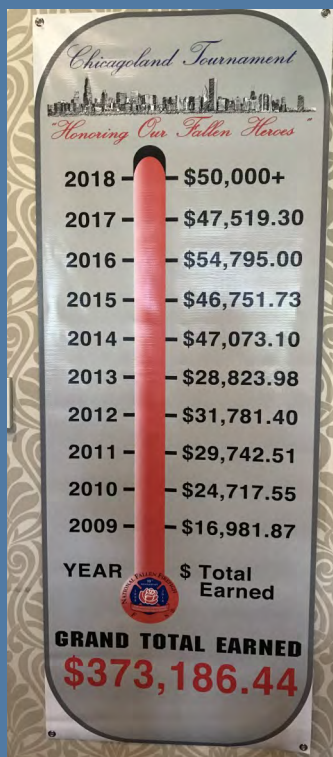

Annual In School Education Program

The District has continued to work with the administration for schools that reside within our District. The 2nd Grade Fire Safety Program has continued in the District 16 schools for the past 10 years. This past year, the students were evaluated at the beginning and end of the 7 month program.

- ◇ 63% of students went from fail (60% or lower) to pass (80% or higher) on the fire safety quiz, bringing 99% students to an acceptable fire safety knowledge level
- ◇ 100% of students increased their overall quiz score over the course of the program

Fire Prevention Bureau Report



The Fire Prevention Bureau has undergone a few changes in 2018. The Fire Marshal's position became part-time at 20 hours per week. A new part-time inspector was hired for a total of two part-time inspectors.

The industrial vacancies that were abundant in the 2008 financial crisis have rebounded nicely with near full occupancy in our fire district. The bureau experienced an increase in building remodels as well as an increase in occupancy of business and factory spaces.

Surprisingly, there were many new construction starts for our commercial businesses. A Jeep dealership, Popeye's/Kentucky Fried Chicken and Freddy's Custard and Steak Burgers are all looking to go in on the North Ave. strip of the District.

Spraying Systems Auto Jet Division has moved into 100 Lake Drive. Shelby's Food and Slot Machines opened, as well as the sister location known as Stella's on North Ave. Herbst High Performance Auto repair moved into 1244 Bloomingdale Rd and Family in Faith Church opened up a long awaited food pantry on their property.

G. Stanley Hall School finished a large addition and remodel. Both G. Stanley Hall and Reskin schools (District 15) received a grant to install fire sprinklers in their buildings. Other upgrades to the fire alarm systems were completed as well.

Fire Prevention Bureau

Medefil Inc. continues to expand at 405 Windy Point and are remodeling 250 Windy Point as well. Hydac has purchased another building and desire to acquire two more. That will make six buildings they own, employing hundreds of workers.

The Glendale Lakes Townhomes have completed their transition from old fire alarm board to individual wireless fire alarm transmitters. North Star Metals now has three locations in Glendale Heights with their newest one at 70 Exchange Blvd. New business, Nongshim moved into 194 Exchange Blvd and are a warehouse for Ramen Noodles.

Glen Oaks has finished with all of their phase work this year. Day surgery, a new doctor's lounge and the entire behavioral health wing were included in this phase of work.
