Chief's Welcome & Notes



On behalf of our elected Board of Trustees and members of this Fire District, thank you for your interest in our department and I hope that you find this report useful and informative.

2020 was not only a busy year but a year of adapting to turmoil and change including handling medical emergencies during a pandemic, along with civil unrest and political conflict. We saw an increase in mental health emergencies as people struggled to cope with the challenges of being “locked down” and having to be distanced from friends and family. Our business community suffered from having to deal with a reduced work force as a result of the pandemic and a lack of business caused by the economic slowdown. Our restaurants were challenged with providing meals curbside and operating without their indoor dining facilities to bring in much needed revenue.

Expressions that a year ago made very little sense became commonly used; COVID-19, socially distanced, remote learning, virtual meetings and we learned about N-95 vs. KN-95's as well as three ply face coverings are better than single ply. Disinfectant wipes, toilet paper and hand sanitizer were hard to find. The way we shopped changed and we learned about curbside pickup, one way aisles, how face coverings must be worn and to stay six feet apart from other customers. We were educated on “lockdown” and who essential workers were and the differences in vaccines and virus strains. We dealt with closed businesses and the increased demand on home delivery carriers and online resources.

Glenside used social media extensively to get our fire safety messages across to the public and into the schools where we used to be seen in person. Our two biggest events where we interact with the public - Glendale Heights Fest and Family Health and Safety Fair were cancelled, and we hope they can resume and we get to be there in 2021.

Glenside was fortunate to hire firefighter Kayla Debelevich in July to replace firefighter Lt. Walter Siewierski who retired after 30 years of service to the District.

In 2021 we plan on expanding our CPR training curriculum to include additional opportunities for those wishing to learn this life saving technique. We are hoping to be back attending public events where we can interact with our citizens and answer any questions that they might have.

The members of the Glenside Fire Protection District take great pride in providing the residents and visitors of the District with quality cost effective care each and every day.

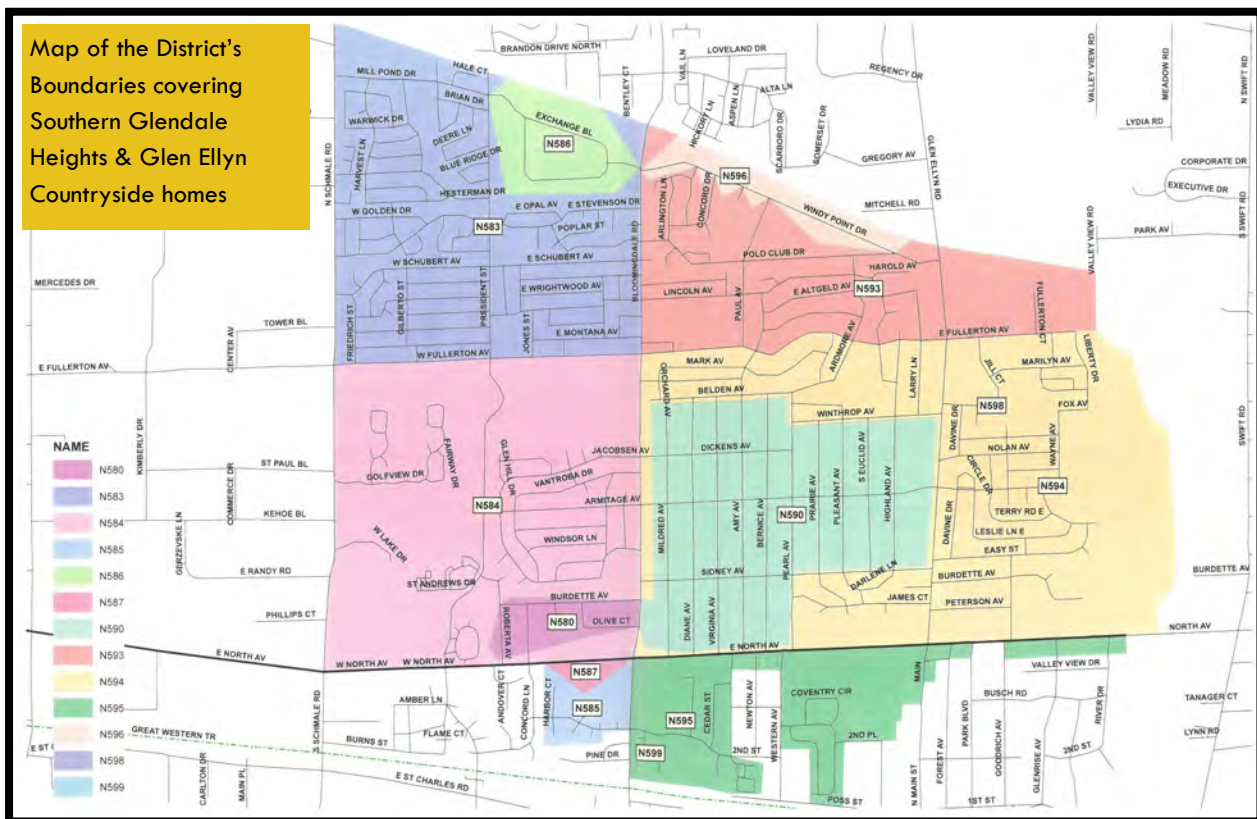
District members responded to 2,338 requests for service in 2020, a decrease of 4.7% over 2019. Of the total responses 1,431 were Emergency Medical Services related and accounted for 61.2% of all calls this year (5% below 2019 numbers). Our Paramedics and Emergency Medical Technicians logged 1,503 ambulance runs on which 686 of those provided advanced life support services to patients.

Fire data includes 70 fire specific incidents and 142 hazardous condition incidents (with no fire). There were also 176 service related calls with the primary reason to provide an invalid assist (103 incidents) and 118 good intent calls - dispatch cancelled, smoke scare or no incident found of the 519 total false alarm related calls.



Glenside Fire District History

The Glenside Fire Protection District was created in June of 1969 through a referendum approved by the voters of the Glen Ellyn Countryside unincorporated area and the voters of the Village of Glendale Heights. In October of 1970 a new fire station was dedicated and held 6 pieces of fire equipment and provided a training room and living areas for the firefighters. In 1984 there was an addition of two long apparatus bays on the west side of the original building and in 1994 a two phase renovation project was started. The first phase, the renovation of the apparatus bays and the underground fuel storage tanks was completed during 1994. However, the second phase, the demolition of the meeting room and living areas of the original building and the construction of new living areas and administrative offices had to wait for funding. In March of 2002 the residents of the Glenside Fire Protection District voted to approve a \$3 million bond issue to renovate the 32 year old fire station. On July 31, 2004 the dedication of the renovated fire station was opened to the citizens for their inspection. The building which was funded by the citizens is expected to serve the community for the next century.



Glenside District Profile

The Glenside Fire Protection District, formed by its citizens in 1969 was organized under the general laws of the State of Illinois providing for the organization and operation of fire protection districts and is now under the provisions of the Fire Protection District Act of the State of Illinois, as amended (70 ILCS 705/0.01 et seq.). The District is located in west suburban DuPage County, approximately 25 miles West of the City of Chicago.

Each day, 24 hours a day, a minimum of five persons are on duty to respond to a variety of emergency incidents. Monday through Friday from 8 a.m. until 4:30 p.m. an administrative staff of five additional personnel are on duty. Fire Chief Russell Wood and Deputy Chief Richard Cassady manage the daily operations. The three Trustees are elected by the citizens of the fire district to administer the funds and set policies for the District. The three Commissioners are appointed by the Board of Trustees and serve to support the hiring and promotional processes of full-time firefighters for the District.

The District is a multi-million dollar operation protecting 34,000 citizens in the community 24 hours each day 365 days each year. The District is proud to have an ISO Class 2 rating and was OSHA inspected during 2017 with no violations.

The District provides a full range of services to its residents including, but not limited to: fire suppression and emergency medical services, hazardous materials response, fire prevention and public education, juvenile fire setters and various community events.

Glenside District Purchases

The Glenside Fire Protection District made a few capital expense purchases in 2020 beginning with a new front-line ambulance. The ambulance is manufactured by Horton and built by Foster Coach Sales, Inc. The final cost of the ambulance with all necessary equipment (radios, lettering, etc.) was just over \$282,000.

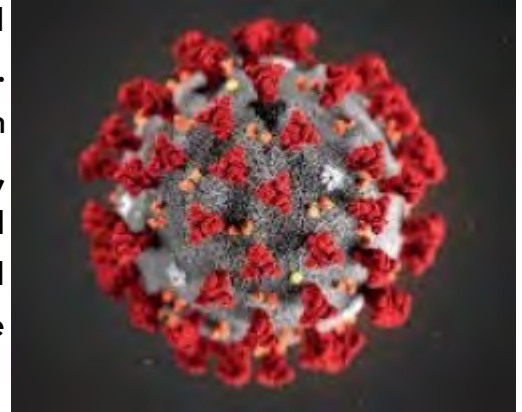
The District also through vehicle rotation, purchased a new buggy for the Deputy Chief and sold one of the older fire prevention bureau vehicles in the fleet. The DC's vehicle was also equipped with lights, radios, command boards, etc. The final cost of the vehicle was \$56,200.

THE YEAR OF COVID-19

The COVID-19 pandemic, also known as the coronavirus pandemic was originally identified in December, 2019 in Wuhan, China and was declared a pandemic in March of 2020. COVID-19, is caused by severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) and is a virus that spreads through the air, through contact or via contaminated surfaces. Social distancing (a minimum of six feet) and face masks became the new normal for everyone. Preventive measures to reduce the chances of infection include staying at home, wearing a mask in public, avoiding crowded places, washing hands with soap and water for 20 seconds, etc. Those effected were advised by the CDC (Center for Disease Control) to quarantine at home unless medical care was a necessity.



This world-wide pandemic by the end of calendar year 2020 had more than 109 million confirmed cases with more than 2.4 million attributed deaths. The responses to the pandemic have resulted in global social and economic disruption, including the largest global recession since the Great Depression. The pandemic led to the cancellation of events, the closing of educational and public areas, as well as widespread supply shortages (exacerbated by panic buying... did you get your toilet paper?). The pandemic has raised issues of racial and geographical discrimination, health equality, and the balance between public health imperatives and individual rights.

The District provided manpower and assistance to get an emergency tent up and running the same day it was requested through MABAS Division 12. The outside shelter was utilized by AMITA Glen Oaks staff to screen patients for Covid-19 before allowing them to enter the hospital.



Chief Wood, Acting Officers Hammond, Hauser & Taylor, Firefighters Francik, Gravina, Johnston, Malkin, Wick and Paramedic Greengard helped move and setup equipment. Glenside District once again to the rescue!



Healthcare workers on the front lines of the pandemic risked exposure to the coronavirus daily, posing obvious risks to their physical health as well as their mental health. By the end of 2020, the healthcare workers were experiencing burnout, stress and feelings of being overwhelmed - for some, conditions compared to a war zone on the front lines.

The District personnel responding to its residents encountered over 129 patients who were either experiencing COVID symptoms or were already diagnosed COVID positive and attempting to quarantine at home.

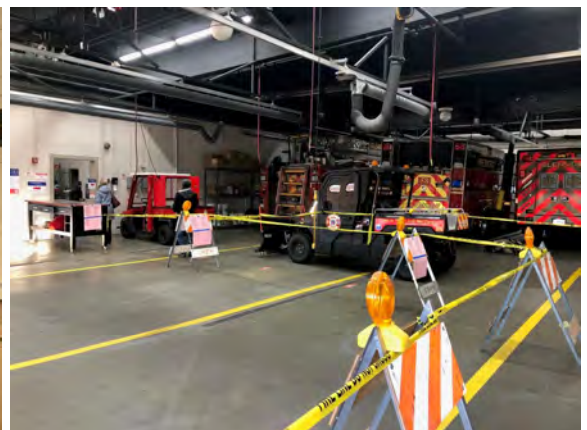
The District took measures to ensure that their personnel were safe. A UV light was installed on the station air handling system to provide Ultraviolet germicidal irradiation, which tests showed can be used to kill COVID-19. The District also ensured enough personal protective equipment (PPE) was on hand as well as looking outside the box for some creative measures.



While supplies grew short across the country, the personnel brainstormed on unique ideas to reuse rain suits and other outer gear by fogging them after use. A make shift disinfection box was created by Paramedic/FF Mike Guevara. The UV-C bulb inside the box would “clean” anything placed inside.

The Coronavirus Preparedness and Response Supplemental Appropriations Act went into law in March, 2020 on a national level. Funding became available to the District through DuPage County, IEMA and FEMA. The District was able to recoup about 75% of the expenses related to the COVID outbreak, which included cleaning costs, supplies, and labor - overtime wages due to illnesses in the later half of the year.

While many employers sent their personnel home during the Illinois Stay at Home mandate, essential personnel were exempt and expected to continue their commitment to the public. Procedures were put into place for personnel to check their temperatures twice a day and to self-monitor for any symptoms or illness. The District was able to keep the majority of personnel healthy from March through September and then experienced a string of COVID positive cases among the ranks. As far as we can tell, all positive cases were contracted outside of the work environment.

Towards the end of 2020 the District received a variety of signs of appreciation from cards and signs being dropped off, to calls from residents and surprise videos sent from the school districts from students.



Chief Wood on behalf of the District wanted to recognize the dedication and hard-work of the men and women of the Glenside District by giving them a 2020 COVID-19 challenge coin of remembrance (right).



There is no specific, effective treatment or cure but for the more serious cases supportive care, which includes treatment to relieve symptoms, fluid therapy, oxygen support, medications or devices to support other affected vital organs have been used.

Throughout 2020, a variety of vaccines were being created and trialed - vaccines were first administered in December 2020. Glenside personnel began to receive vaccines in late December 2020 through AMITA Hospital for the first round of trying to reach essential personnel.



Glenside Fire District Training Center

What appears to be an average home in the neighborhood on the outside is really quite different on the inside. Since the Fire District purchased this home, adjacent to the fire station in August of 2017, many of the members have worked diligently to transform the inside into a very valuable training facility. When the home was identified as available, the training committee immediately identified the fact that most fire training facilities have very limited furniture or simulated furniture in them because of the fuel load restrictions. Purchasing the house allowed our members to donate or build simulated furnishings to create a true mock up of a fully furnished home on the inside which can get splashed with water or banged around without worry about the accumulation of harmful mold.

One of the bedrooms has a mockup of a set of bunk beds, another has a captain bed and crib, as well as dressers and other furnishings. This allows training simulations to feel more realistic to firefighters as they have to be conscious of their surroundings and cautious in a smoke filled room.



Training exercises and evolutions are performed on a regular basis utilizing the internal and external areas of the house. Manipulation of rooms in the home are constantly updated and changed to challenge the firefighters and to refresh basic skills.

House Training Evolutions and RIT took place on January 29th and 30th

Even in the winter months training still continues! Shown below, a replica roof prop was built with replaceable plywood at the end of 2019 so firefighters can continuously utilize practicing vertical ventilation skills. The pitch of the prop can be altered to simulate a variety of roof pitches, allowing for practical application.



The property is being used to train firefighters in disciplines such as single family structural firefighting, emergency medical services, hazardous materials and specialty rescue responses.

Cooperative training exercises are also made available to neighboring departments and other organizations like MABAS Division 12 and the Village of Glendale Heights Citizen's Police Academy.

Firefighters practice opening a locked door using a forcible entry prop. A valuable tool when teaching and practicing skills for opening doors. The prop was on loan from the Elmhurst Fire Department for several weeks. (Pictured right)

One of the last training exercises of the year for Lt. Walter Siewierski and his shift took place in late January of 2020. The smoke machine was used inside to simulate a fire on the second floor of the home during this Rapid Intervention Team (RIT) drill.



The training committee members are continuously working to change and improve the props, patterns and simulations in and out of the training house. Pictured below several firefighters are running drills to practice forcible entry, hose advancement, and other critical training exercises.

Practicing in a non-hazardous environment assists firefighters to improve their speed, proficiency and readiness for performing on an emergency scene when they arrive on calls. Assessments are completed after training exercises to discuss what went right and what went wrong for learning opportunities.



Station Projects / Foreign Fire Board

Foreign Fire Insurance Board

The Glenside Foreign Fire Insurance Tax Board was created in 2010 within the department to receive and authorize the expense of funds for the maintenance, use and benefit of the District as well as its members as designated by Illinois State Statute. The Illinois Municipal League collects 2% of fire related taxable premiums from out of state insurance companies with policies in state to provide to all fire departments. In 2020 two checks were received and \$38,720.36 was provided to the board.

The Glenside Foreign Fire Insurance Board completed another great year of focusing on the needs of the District and its members. The board continued to approve money to be spent on kitchen supplies that benefit all shifts and employees. Scholarships for education and training are also made available to all employees in the amount of \$3,000 annually.

They also approved the purchase and completed installation for reverse osmosis filters for both the upstairs and admin kitchen sinks. The filtered drinking water stations continue to be used and now show that the equivalent of over 11,600 disposable plastic bottles were eliminated from our waste system on the main floor alone. The number had been 8,900 at the end of 2019.



In 2020, the board also approved expenditures for new battery operated extrication equipment for which the cost was split with the District. Other expenses included new towels and sheets for upstairs, new coffee maker and other kitchen equipment. The training chairs for the District were replaced after several samples were tested out. The board is also collecting information to replace the kitchen table in the upstairs living quarters with a longer, wider and better built custom table.

A Peleton Bike had been purchased in 2019 to add to the fitness equipment in the workout room, providing a heart pumping cardio experience for users. A monthly membership is covered for all employees by the Board. Future purchases are consistently being considered by the Board and monies are set aside through a reserves process for larger purchases.

District Programs



Sharps Disposal Program

The District is proud to continue to be the leaders in DuPage County fire districts with the Sharps Disposal Program implemented in 2015. We continue to use a portion of the IPRF Safety Grant money to support the cost of the Sharps Program and assist not only the citizens of the District but we also never turn away anyone disposing of sharps. In 2017, the Village of Glendale Heights waste disposal company, Republic Services, contracted to partner with us and now provide a supplemental payment to the program annually. Donations are also accepted from all non-residents who are able.

The program has grown since its inception (see the disposal chart below) and is not only appreciated by those utilizing the program but encourages everyone to reduce their carbon footprint within our environment. Programs in Cook County have grown and DuPage is looking to implement their own changes in the new year.

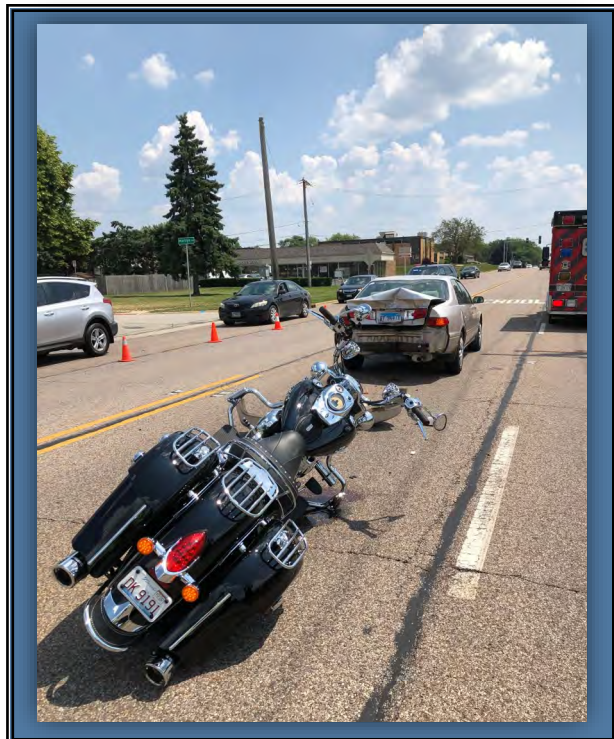


Incidents and Fire Loss



A car in the ditch off of North and Western Avenues in June proved to be a small challenge as the rescue of a family was made (above left).

In July another vehicle off of North Ave near Sunrise Chevy and Glendale Nissan car dealerships (above right)



In July a motorcycle versus car incident took place off of Bloomingdale Road and Marilyn. In most cases you see the opposite impact of vehicles, but this one occurred due to the motorcycle failing to reduce speed for a car making a left turn.

Noteworthy Facts:

4 extrication calls took place in 2020 of the 86 motor vehicle related incidents.

128 hazardous condition calls (with no fire) were primarily related to gas leaks (47), carbon monoxide (29) and power lines being down (39)

Incidents and Fire Loss



A small house fire on Fullerton on June 15th brought auto aid to the scene to assist our Glenside Fire Personnel. The fire started in the dryer and extended to the structure.



Chief Wood was command on the scene along with Gold Shift's Lt Cavanaugh, AO Hauser, Thank you to the neighboring departments for their assistance on this call.



Note:

Fortunately the residents were home and were able to evacuate safely with no injuries. The fire was quickly brought under control.



Incidents and Fire Loss



A home on Mark Ave in September called our Glenside Fire Personnel to the scene for a smoke investigation (pictured left and below).

Note: Residential fires caused \$240,000 in estimated property loss for homeowners and 2020 but saw \$0 in merchant/business property loss.

Only 4 cooking fires were recorded (5.7%) of fire related calls in 2020.



A garage fire on Bloomingdale Road on January 25th (pictured right) shows Chief Russ Wood surveying the aftermath with the responding crew. The vehicle and entire garage were lost in the fire.

There were 13 fire investigations completed by District Fire Investigators in 2020.

A mutual aid call in Glendale Heights brought out our crew to assist Bloomingdale Fire for a fire on the roof of a large occupied manufacturing business just after midnight on November 21st.

Lt Lipowski and other members of Black Shift along with EMS personnel were on scene.



Another large garage fire on Schubert in September brought auto and mutual aid to the Glenside scene.

Red shift and Lt. Mike Pacie found Fire Investigator Kyle Lipponeur had determined that the fire's origin was due to an un-maintained clothes dryer kept in the garage.



Incidents and Fire Loss



A house fire on Vantroba in July brought auto aid companies and Chief Wood out during the night.

Firefighters take the garage door apart to get to the inside door of the home (pictured left).

The fire was believed to have started in the garage from an electrical cord with a charging device attached. The homeowners were able to exit safely with no injuries.



All crews on scene work together to fight the fire and ensure that it is out (pictured above, left). Glenside personnel check for hot spots near the home's roof (pictured above, right).

Noteworthy Facts:

Fire related calls: There were 42 building fires accounting for 60% of all fire related incident calls (70).

Black Shift took the most calls in 2020 with 37.64% of all calls; the District was busiest on Wednesdays and slowest on Saturdays.

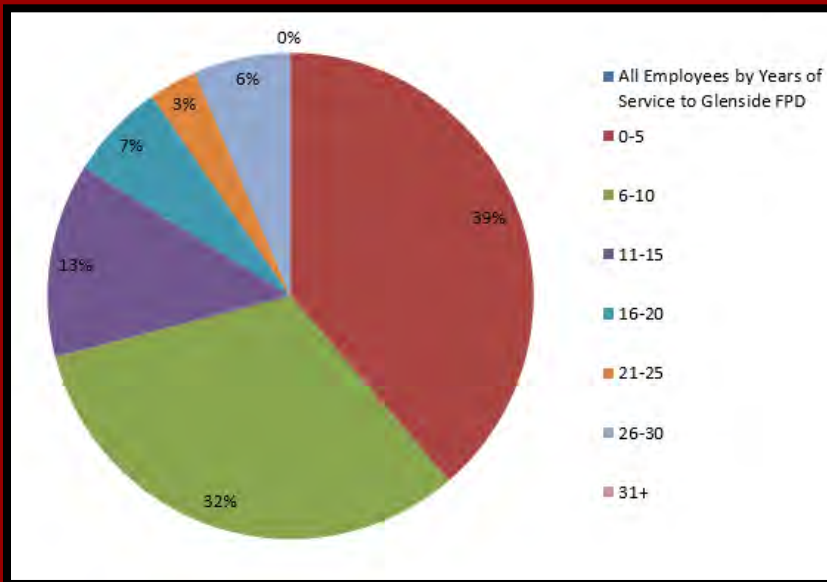

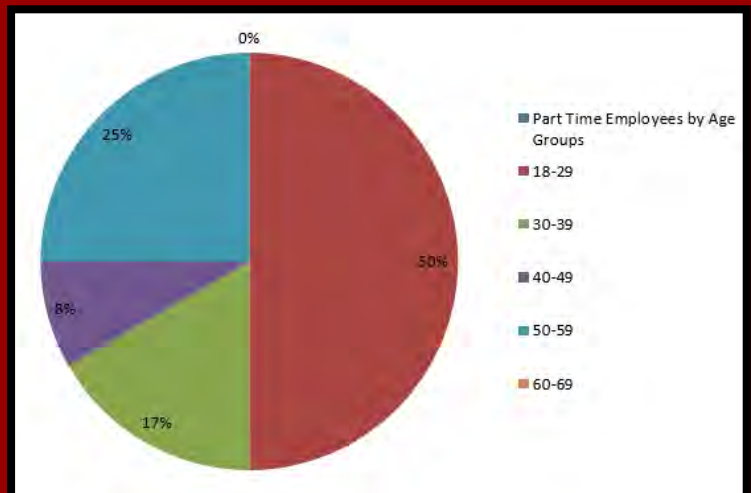
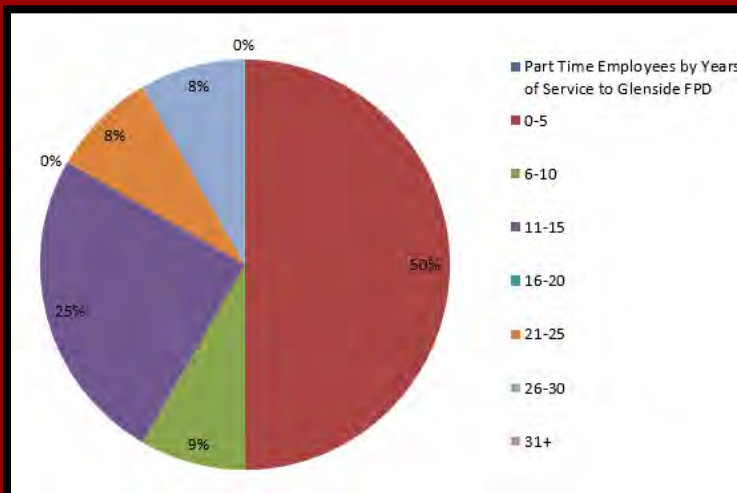
DISTRICT DEMOGRAPHICS



Graph charts show the demographics of the District members by years of service, all employees (left), and part-time (left center).

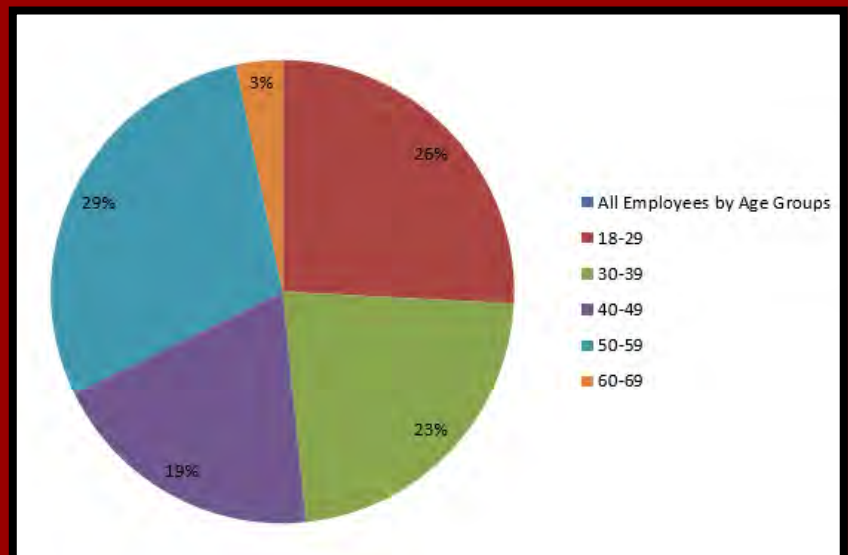

New Firefighter Orientation includes a ten-day orientation process in which candidates work through a detailed program to evaluate their current knowledge level and provide training on Glenside specific policies, procedures and equipment. During this process candidates participate in multiple fire and ems related drills utilizing various equipment carried on Glenside Apparatus. Candidates are also given a thorough tour of the Fire District in which the various Target Hazards and intricacies such as the non-hydrated areas are pointed out.

Also during this time candidates, complete the process of entering the Good Samaritan Emergency Medical Services System which for Paramedics includes a written exam, skills assessment, and clinical experience in a system Emergency Department. Following the ten-day orientation process, candidates then continue to work on completion of a Candidate Orientation Book which involves approximately a year long process of meeting objectives and demonstrating competencies which are laid out in this manual.

Normally career and part-time members train together every Wednesday night. Training covers a number of disciplines such as structural firefighting, Hazardous Materials responses or technical rescue and EMS. Wednesday night drill training was put on hold in March/April of 2020 due to Covid. Only shift training at the house next door continued for the remainder of the year.

The importance of an onsite training house was quite evident as offsite facilities were essentially shut down due to Covid and the cancellation of multi-company and MABAS drills was seen across the State of Illinois.

The chair enables paramedics to move patients from upper levels in their homes to an awaiting cot and helps to alleviate lifting injuries to the firefighters. The owner was elated when the dog reached safety.



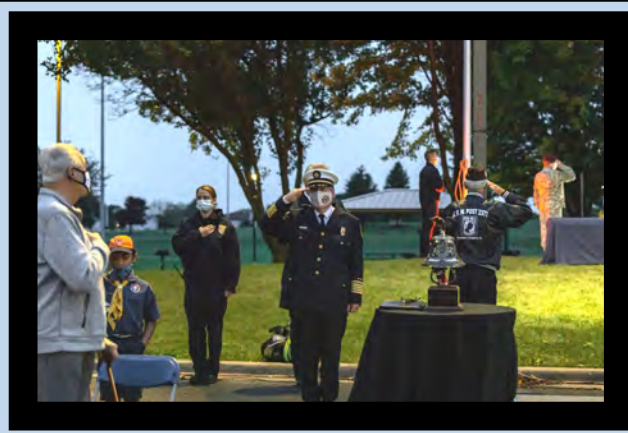

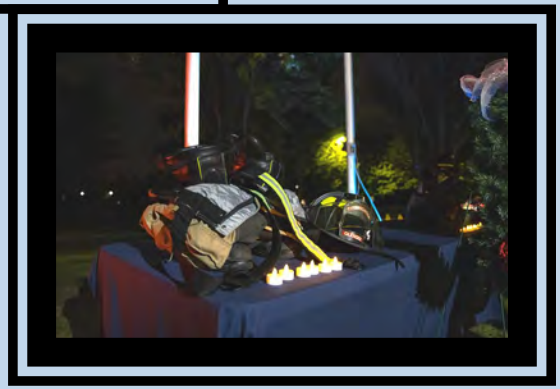

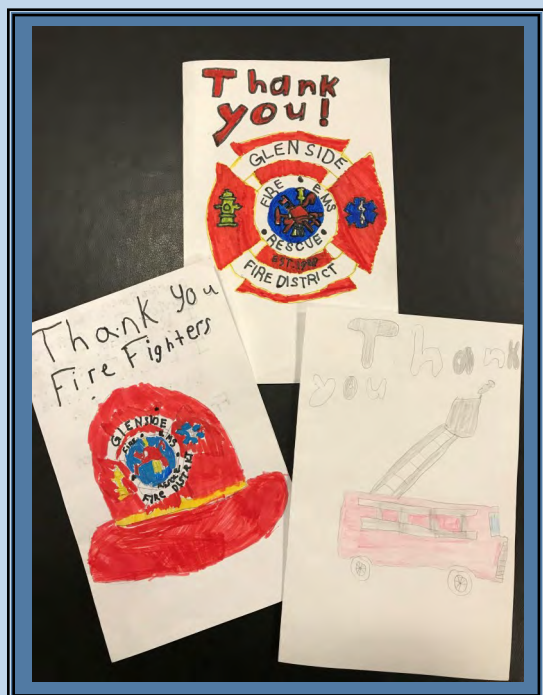


Glenside Community Commitment...

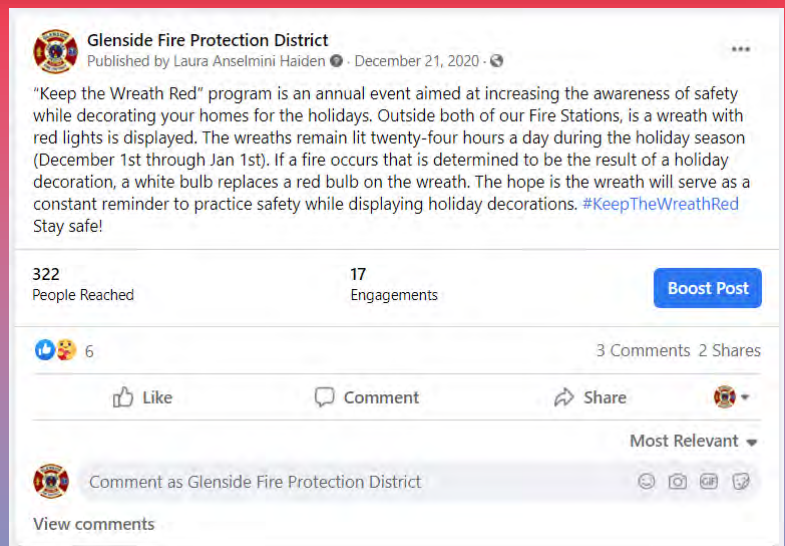
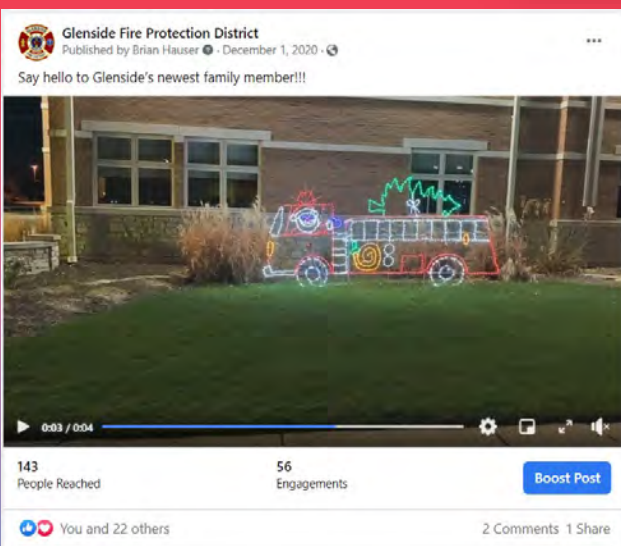
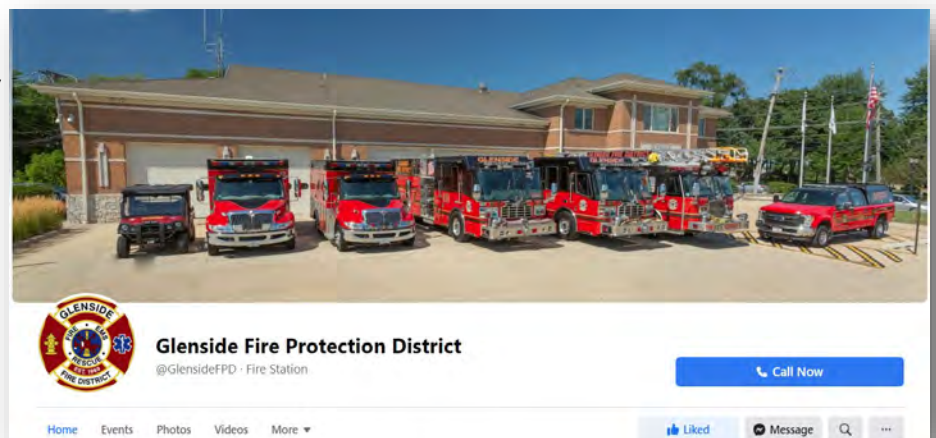
Park Parties—Safety Town—Glendale Heights Fest

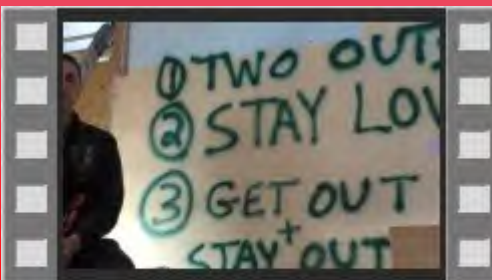

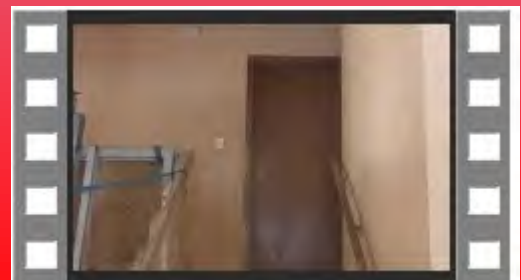
Annual In School Education Program

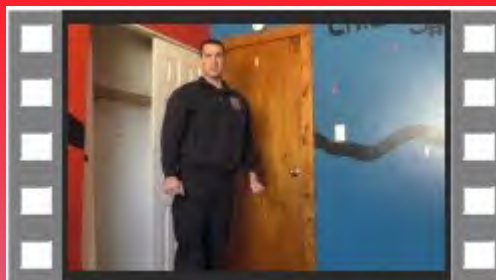

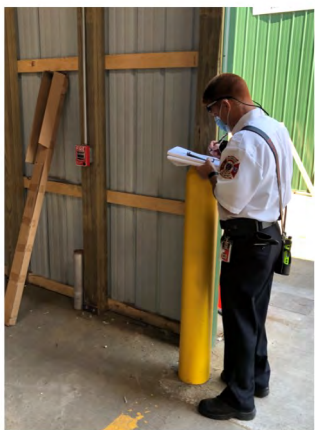
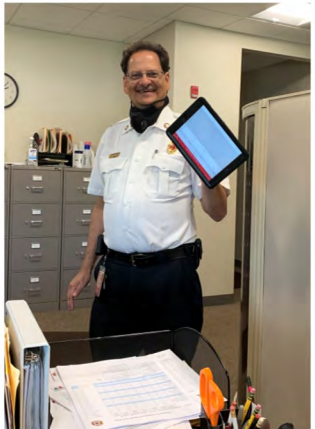

With that said, due to the foresight, commitment and effective safety procedures initiated by our chief officers, administrative staff, trustees and commissioners, the Fire Prevention Bureau (FPB) was able to successfully deliver safe, considerate, uninterrupted and timely service to the businesses and citizens of our district.

We are happy to report that our iPad based fire inspection program has been a tremendous success. Our goal to eliminate unnecessary redundancy, expand our level of communication, streamline the fire inspection process and decrease the amount of time between fire inspections couldn't come at a better time. Although we did not reach our goal which was to offer an annual fire inspection for the over 500 occupancies that currently reside within our fire protection district, we have laid the crucial groundwork for future compliance and will be able to better analyze a full year worth of data at the end of 2021. Our goal is to extend the new iPad firehouse inspection program to include additional inspection checklists.

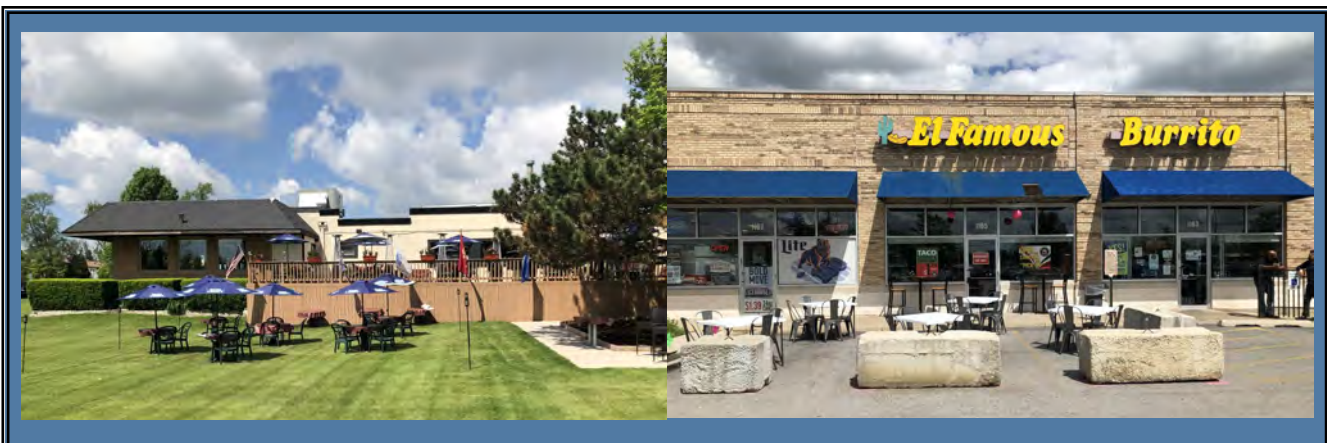
Opening—February 12, 2020

Fire Marshal Brad Butler joined Mayor Jackson and staff at the ribbon cutting ceremony.

As a result of our commitment to improving service, enforcement and compliance, we established an agreement with BRYCER, a third party compliance engine, to help us manage the anticipated increase in inspection report reviews. We look forward to implementation and are excited as we continue to integrate new technology and welcome new partners into our evolving service strategy.

Phase 1 of our plan to scan and archive all plans and documents has been completed. Phase 1 included all fire alarm and sprinkler plans. We now have quick and easy access to these scanned plans and use them on a daily basis. We hope to begin and complete phase 2, which will include all other plans that are important to the FPB, including kitchen hood and suppression systems, architectural, mechanical and electrical drawings.

The challenges of Covid for restaurants in 2020 required businesses to alter the way they do business, forcing customers to order pickup or dine outside at places they normally might not do so. This situation led to additional partnership with the Village on inspections keeping life safety in mind at all times.



Fire Prevention Bureau

In 2020, we installed 44 smoke detectors with 11 of them being part of the Be Alarmed Smoke Alarm Installation Program. Statistics for the OSFM's program are shown in their 2020 Impact Report (pictured right). New ten-year smoke detectors are available in stores and no longer require that batteries be changed. The District keeps a stock on hand for resident convenience and requires a discounted cost donation.

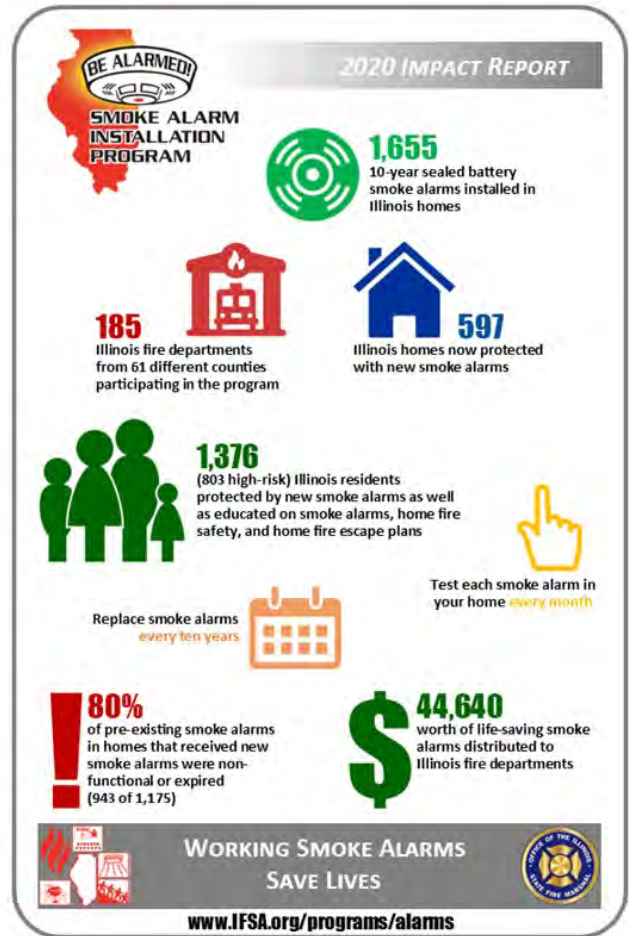

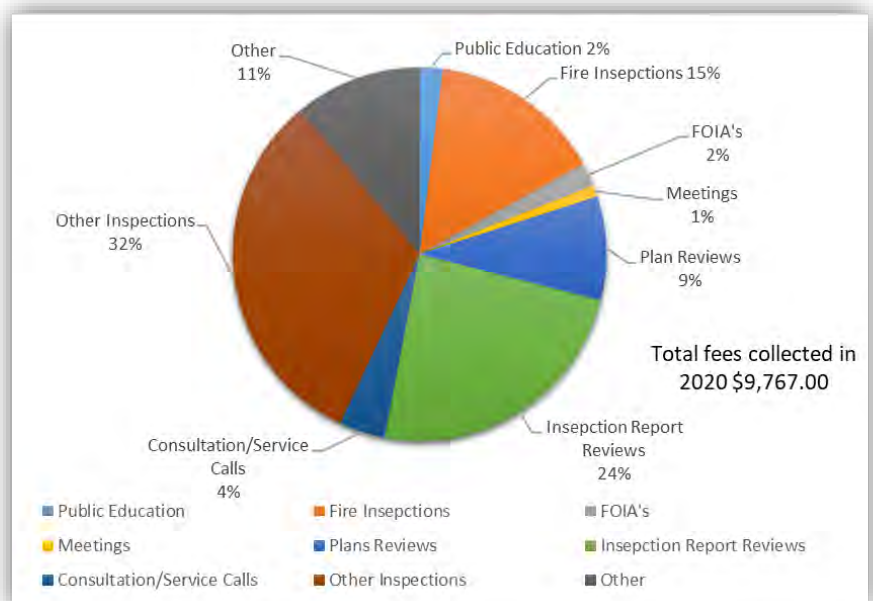

The following pages provide reporting data generated from Firehouse Software, a National Fire Incident Reporting System (NFIRS). This is the compliant reporting and records management software system the District utilizes to track fire and emergency medical services (EMS) calls. This system also tracks the scheduling of firefighters, training, equipment, public education events and many other fire department related information that requires tracking. The District also tracks specific training, certifications, legal requirements and other data in Target Solutions.

EMS call records are supported by additional information through the Image Trend System and the billing process with an outside contracted billing company.

In 2020, the District increased their ambulance service rates with consideration to new Ground Emergency Medical Transportation (GEMT) allowable rate increases. The District also added car fires to the billing process through Paramedic Billing Services.
